RESIGNATION OF INDEPENDENT NON-EXECUTIVE DIRECTOR

CW Group Holdings Limited (In Provisional Liquidation) (the “**Company**”) hereby announces that with effect from 9 June 2019, Mr. Chong Eng Wee (“**Mr. Chong**”) has resigned as an independent non-executive director due to personal reasons and other work commitments. Upon his resignation, he has ceased to be the chairman of the remuneration committee and a member of the audit committee.

Mr. Chong has confirmed that he has no disagreement with the board of directors of the Company and that there is no matter in respect of his resignation that needs to be brought to the attention of the shareholders of the Company.

The Company would like to express its gratitude to Mr. Chong for his valuable contribution to the Company during his tenure of office.

Following the resignation of Mr. Chong, (i) the number of independent non-executive directors will continue to fall below the minimum number required under Rule 3.10(1) and 3.10A of the Listing Rules; and (ii) the number of members of the audit committee will continue to fall below the minimum number required under Rule 3.21 of the Listing Rules.

The Company is in the process of identifying suitable candidates to fill the vacancies of independent non-executive director as soon as practicable as required under Rule 3.11 of the Listing Rules. Further announcement(s) will be made by the Company in this regard as and when appropriate.

SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been halted with effect from 3:22 p.m. on 11 July 2018. Trading in the shares will remain suspended until further notice.
